**PROPERTY CODE 12.001 (a & b)**

An instrument concerning real or personal property may be recorded if it has been acknowledged, sworn to with a proper jurat, or proved according to law. An instrument conveying real property may not be recorded unless it is signed and acknowledged or sworn to by the grantor in the presence of two or more credible subscribing witnesses or acknowledged or sworn to before and certified by an officer authorized to take acknowledgements or oaths, as applicable.

**VTCS ART. 3930c**

The clerk should examine the document to make sure that all parties to the instrument are clearly identified as to name. In two party documents, these parties will be the grantor(s) or grantee(s). All names shall be typed under the signatures or there will be a charge of double the recording fee for that page.

**THE CLERK SHALL CHARGE REASONABLE FEES FOR PERFORMING OTHER DUTIES PRESCRIBED OR AUTHORIZED BY STATUTE FOR WHICH A FEE IS NOT PRESCRIBED BY THIS SUBCHAPTER. (Sec. 118.011(c) LGC)**

**CONTENTS AND RECORDING OF ABSTRACTS OF JUDGMENT:**

Section 52.0041 Property Code:

- (a) A judgment abstracted after September 1, 1993, may not be recorded unless:
  - (1) a mailing address of each plaintiff or judgment creditor appears on the abstract of judgment; or
  - (2) a penalty filing fee equal to the greater of \$ 25.00 or twice the statutory recording fee for the abstract is paid.
- (b) The validity of an abstracted judgment as between the parties is not affected by a failure to include an address for each plaintiff or judgment creditor in the abstracted judgment.
- (c) Payment of a filing fee and acceptance of the abstract of judgment by a Clerk for recording creates a conclusive presumption that the requirements of this section have been met.
